

**CURE Insurance Arena 12 Days of Holiday Giveaways Sweepstakes**  
**December 13, 2019 – December 24, 2019**  
**Official Rules**

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN. VOID OUTSIDE NJ, PA AND DE AND WHERE PROHIBITED.

1. ELIGIBILITY: The CURE Insurance Arena 12 DAYS OF HOLIDAY GIVEAWAY Sweepstakes (the "Sweepstakes") is open to our followers. By successfully following the instructions of each post (i.e. like, comment, share, etc.), you will be entered in the Sweepstakes. LIMIT ONE (1) ENTRY, PER PERSON, PER DAY. Additional entries beyond the specified limit will be void. For the purposes of these Official Rules, a "day" will start at 12:00:00 p.m. ET and end at 11:59:59 p.m. ET (except for the first day, which will start at 1:00:00 p.m. ET). Sponsor's computer will be the official timekeeper for all matters related to the Sweepstakes. Entries generated by script, macro or other automated means and entries generated by any other means which subvert the entry process will be void. All entry data provided via Facebook and cyber club entry is provided to Sponsor and not to Facebook.
